Delivery of Registration

I agree contemporaneously with the execution of this document to deliver to HER a properly signed transfer of all registration papers for the above described equine, omitting the name of the transferee.

Other Pertinent Information

I also agree to provide HER with any documents and all other available information concerning this equine which might assist in matching this equine with the proper prospective adoptive home, including health and immunization records, pedigree(s), name(s) and address(es) of breeder(s) or other person(s) from whom the equine was acquired, and information concerning this equine's history such as important life events and individual personality traits.

Consent for Contact

I understand that HER may contact the breeder(s) or previous owner(s) of this equine to obtain additional background information, or otherwise assist in locating a suitable adoptive home, and hereby give or consent these efforts.

Surrender of Rights

By executing this document I understand that I am giving up forever all rights to, titles to and interests in the above equine and I further understand that all future decisions regarding the placement of this animal will solely be those of HER. I also understand that if this equine is found to have an unpredictable temperament unsuitable for any placement, or if the animal's quality of life is substantially impaired, in the opinion of a competent veterinarian, by chronic, irreversible, painful condition, euthanasia may be considered as an alternative to adoption.

I understand that Hope Equine Rescue, Inc will make every effort to find a suitable home for my equine following its normal adoption procedures, with certain exceptions (i.e.: those that must be euthanized upon recommendation of a licensed veterinarian.) I hereby surrender all right, titles, and interests in the above referenced equine voluntarily and without coercion or threats of any kind.
